Signs/Symptoms: Metoprolol Tartrate Injection is a drug generally used as a beta-blocking cardiac drug that affects the circulatory, central nervous and digestive system. Minimal adverse health effect should occur from routine use under care of a physician with this product. Chronic effects may be toxic to a developing fetus.

SECTION 4 : FIRST AID MEASURES

Eye Contact:	Immediately flush eyes with plenty of water for at least 15 to 20 minutes. Ensure adequate flushing of the eyes by separating the eyelids with fingers. Get immediate medical attention.

Environmental Precautions:	Avoid runoff into storm sewers, ditches, and waterways.
Methods for containment:	Contain spills with an inert absorbent material such as soil, sand or oil dry.
